- Bylaw change to allow senators to be sat on three internal committees
- It may seem like there are only two senators interested, but this would make it permanent and allow the change to apply to everyone
- Momaney: was sat unbiased, but people in Rules were against the change, however we allow you all to make a change, just keep in mind that only two people want to do this. You already have a lot of responsibilities, and we want to allow people to be involved outside of committees so you don't exert yourself. You are students first, and you all should remember that.
- Azhan: I do agree with Momaney, I oppose the idea of a bylaw change. We can always go back and waive the bylaws as we just did.
- Peddasani: As Momaney said, we would have to renumber and reallocate the number of seats on committees. Thus far, there are only two senators that have done this so I'm not sure this is the best idea until there is overwhelming interest.
- Gopa: Why do we have a cap on this, does it really matter? Motion to change the bylaw to unlimited?
 - Jones: objection
- Aiono-Dimhoff: It says many senators have shown interest, has anyone else shown interest?
 - I used it to say more than one, and for the record, there is no precedent for doing this for any other bylaw changes, I could have but that was not suggested until after first read. I have the new numbers for committees if anyone is interested.
- Jones: What committee do you want to join?
 - I am currently on FInance and Events, and willing to join more if people are interested

- Momaney: I suggested the polling so there was a basis for "many senators" and think about how hectic committees would be if there were unlimited members.
 There is such a thing as too much debate. We want to do efficient work for our constituencies.
- Rowles: While I do get the initiative, when you have such a small group that wants the bylaw change, the need is not there, especially when we can waive the bylaws and most senators are only sat on one.
- Peddesani: We would need to redo the seats as we do not need inefficiency/or people who cannot be on committees, which would change the average to be two committees instead of one for each senators
- Hartley: You would or would not need to renumber those committees?
 - We have 36 senators at full capacity and there are 44 possibilities for committees, so as of right now if we had a full senate only 8 senators could be on 2 committees
 - We would not need to renumber it, as there is not a full senate
